IF YOU WITHDRAW FROM OR DROP ANY COURSE FOR THE ENTIRE SUMMER OR DO NOT REGISTER FOR THE REQUIRED CREDITS YOU MAY LOSE PARTIAL OR FULL LOAN ELIGIBILITY FOR THE SUMMER. IT IS YOUR RESPONSIBILITY TO NOTIFY THE FINANCIAL AID OFFICE OF ANY CHANGES IN YOUR ENROLLMENT. THIS INCLUDES WITHDRAWN/DROPPED COURSES AS WELL AS COURSES THAT ARE CANCELLED.
