- Conditional Admit for Accelerated Graduate Program includes 2.5 average in AC-151 and AC-152 (ACC-121 and ACC-221) and/ or Cumulative GPA of 3.0 or higher, Major GPA of 3.0 or higher, and Cognate Course GPA of 3.0 or higher
- Graduate year may require a summer term in order to fulfill all requirements.
